**CMAA Honors 12 Projects that Display Construction and Program Management at its Best**

A dozen projects, ranging in cost from less than \$10 million to more than \$100 million and spanning the spectrum from a community branch library to a major enhancement of one of America's busiest highways, received "Project Achievement Awards" from the Construction Management Association of America on October 9.

The awards were presented as part of CMAA's Industry Recognition Dinner, concluding the association's 2007 National Conference in Chicago. More than 700 professionals from all over the country attended the conference.

Both award winning CMs and project owners were on hand for the presentation. The winners were selected by an expert jury from among 75 nominees submitted to CMAA earlier in the year.
