Moving California Forward California High-Speed Rail Project

With voter approval of the high-speed rail bond last fall, construction is likely to begin as early as 2011 on an 800-mile statewide system of high-speed trains that will move people and goods like never before. The service would run from Los Angeles, Orange County and San Diego in the South to the San Francisco Bay Area and Sacramento in the north.

California is the only state in the country that already has in place \$9 billion in voter-approved financing, environmental clearances and an adopted route for a true high-speed train. President Obama has dedicated federal stimulus money to eligible high-speed projects, and California is among the top of the list. Once construction begins, the project will be the biggest new public-private partnership venture in America.
